OFFICE ORDER NO. 56 (MA) OF 2025

- The promotion of the above officials will be effective from the date of assumption of charge to the promoted post at the ordered place of posting.
- On promotion, the pay of the above official will be fixed in the Level - 6 of 7th CPC under normal rules w.e.f. the date of joining as Senior Optometrist and pay will be fixed as per the provisions of FR 22(I) (a) (1). The officials may exercise option for fixation of pay within one month from the date of regular promotion.
- The promotion will be subject to such terms and conditions as laid down in ESI Corporation (Staff & Conditions of Service) Regulations, 1959 as

amended from time to time.

- d. The seniority of the officials promoted in the cadre of Senior Optometrist will be determined in accordance with the order of the DPC recommendation.
- e. The officials may intimate his willingness or otherwise to accept promotion on regular basis immediately.
- f. It may be noted that if the officials are unwilling to accept this promotion, the order of promotion will be deemed cancelled and the said official will not be considered for promotion for a period of one year and it may also be noted that in case of non acceptance of this regular promotion, the same would be offered to their junior officials. In such an event, the junior may start drawing higher pay and other benefits, to which the said official who has declined promotion will not be entitled to any relief in future.
- g. The promotion shall be subject to DoP&T OM No. 36012/11/2016-Estt(Res-I){Pt-II}, dated 15.06.2018, i.e., promotion shall be subject to further orders which may be passed by the Hon'ble Supreme Court in SLP (C) No. 30621/2011.
